5. All applicants must successfully pass a background investigation, including but not limited to a criminal history records check that would otherwise prohibit employment as a Medford Police Department employee.
6. None of the above requirements are intended to be automatic disqualifiers. Each factor will be considered in the overall evaluation of the applicant.
